2	The registered office of the Society shall be at:	Sach Khand Ishar Darbar, H.No. 83, Village Jurasi, Tehsil Pehowa, District Kurukshetra - 136128 Haryana
3	Jurisdiction	The Society shall work within Kurukshetra District of the territory of State of Haryana
4	Aims and Objects of the Society	That the main objectives of the Society shall stand to include the objective of spreading of elementary, secondary, higher, technical, para medical, Dental, Medical, Spiritual and any other field or system of imparting education or knowledge to the masses for which the Association shall pursue any or all of the under mentioned:-
(a)	To establish and run schools, Colleges, Universities and other educational institutions and also hostel for students and teachers;	
(b)	To establish and run medical Colleges, Dental Colleges, Homeopathy, Medical Colleges, Colleges of Pharmacy and or Physiotherapy, Engineering Colleges, Computer Training institutions, Schools and Colleges for Business Management, Nursing College, I.T.I. and Polytechnic including graduate and post graduate institutions research projects and associated hospitals which are established for the sole purpose of providing a training ground for these educational institutions;	
(c)	To arrange for lectures, discourses conferences, seminar etc. for dissemination of technical moral, cultural information among group of students, teacher or general public;	
(d)	Where the running of any educational institutions in the field of medicine require establishment of a hospital, nursing home etc. solely for the purpose of providing training for students of medicine such ancillary institutions may be establishment and run;	
(e)	To invite and honour scholar, educationalist and litterateurs and erect status of or monuments in the memory solely by with a view to spread their messages among the masses;	

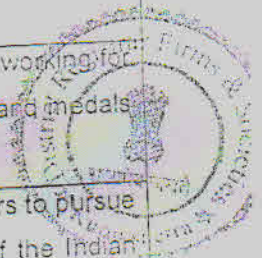

(f)	To conduct research on matters pertaining to science, technology, sociology, theology and philosophy and to publish results of such research;
(g)	To publish books, periodicals and magazines and if required establish a printing press and composing facilities for such purpose;
(h)	To collect aid by donations and contributions of any amount or fund from any individual, trust society, company or any other statutory entity for the promotion of the objectives of the society;
(i)	To make fixed deposits or other investment which may be necessary to obtain government permission, sanction of universities or other government bodies for the running of school, colleges or other educational institutions or hostel land;
(j)	To borrow money from banks or private parties to finance acquiring educational institutions and equipment therein and to accept donations or contributions for the same purpose;
(k)	To set up and promote educational, cultural, social welfare and community health centers/institutions for the benefit of the people of the country;
(l)	To help such persons without distinction of caste and creed, who have sacrificed their lives for the service of the poor people and work for the awakening of ignorant masses of the country;
(m)	To maintain or grant to poor and deserving students or other persons who are working for the education of the people, by scholarship, lumpsum grants, stipends, prizes and medals etc.;
(n)	To provide interest free loans or grants to deserving students and other scholars to pursue their studies in this country or abroad for educational purpose or to those of the Indian Nationals, who want to carry their message of Indian culture to foreign countries;
(o)	To establish, support, maintain or grant aid to maternity homes and child welfare centers, orphanages or widow homes, student hostels and such other institutions for public benefits;
(p)	To provide medical aid and relief to the suffering humanity and needy people by aiding, establishing or maintaining charitable hospitals, medical and technical schools, colleges, dispensaries, nursing homes, health clinics, sanatoriums and similar other institutions;
(q)	To construct and maintain Sarai, Dharamshala, place of worship, to setup Asharams to provide religious education and to establish Nature Cure Centers for the benefits of general public and needy people;

- (r) To establish and promote physical, moral, national activities and cultural education, sports clubs, schools and colleges both for boys and girls and other like institutions for the benefit of general public;
- (s) To help the needy people with food, medicines, clothing or otherwise;
- (t) To acquire by gift, purchase or mortgage, exchange, lease, on hire or otherwise howsoever any lands, buildings, easements and any property movable and/or immovable, transports/vehicles for the furtherance of all or any of the objects of the Society;
- (u) To build, construct and maintain houses or other buildings and alter, extend, improve, repair enlarge or modify the same including any existing buildings and to provide and equip the same with light, water, drainage, furniture fittings, instrument apparatus and appliances and all other necessaries for the use to which each building to be put or held;
- (v) To solicit, obtain or accept subscriptions, donations, grants, gifts, devices, bequests and trusts from any person, firm, company, corporation, institution, Government or semi-Government organization;
- (w) To sell, manage, transfer, exchange, mortgage, charge, lease, dispose of or otherwise deal with any property whatever belonging to the Society;
- (x) To do all such other lawful acts, deeds or things as are incidental or conducive to the attainment of any of the above objects;
- (y) To spread out the teaching, messages & principles of Shri Guru Granth Sahib Ji, their principles among the youth who belongs to the Sikh minority community;
- (z) To promote universal brotherhood without any discrimination of caste, colour or creed through various cultural activities and organizing national and international tours. The main aim of the society is to promote Sikhism and the Society is especially meant for the benefit of the Sikh minority community in particular.



**Conditions:**

The following shall be the conditions of the Society:-

- (i) The income and property of the Society shall be applied solely towards the promotion of the Society as set forth in the Memorandum and no portion thereof shall be paid or transferred, directly or indirectly, to the executive members of the Society for their personal benefit
- (ii) No executive member of the Governing Body of the Society shall be appointed to any salaried office of the Society paid by fees, that no remuneration shall be given by the Society to any Trustees except repayment of out of pocket expenses and interest on
