The sanction is subject to the fulfilment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes :

1. The school will provide additional suitable facilities for classes XI and XII as per requirements.
2. It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for classes XI and XII
3. It will appoint only qualified staff to teach classes XI and XII as per requirements laid down by the Board.
4. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
5. It will abide by the Affiliation Bye-laws of the Board and other rules and regulations prescribed by the Board from time to time.
6. It will remit Annual Fee Rs. 1000/- regularly. (In case of overseas Independent Schools @ Rs. 5000/-p.a. and overseas Kendriya Vidyalayas @ Rs. 3500/-p.a.)

Special Conditions, if any :

1. The school is required to replace 5 PGTs who are not having professional qualification.
2. The school is required to appoint 6 more PRTs to meet the minimum required at the ratio of 1:1.5.
3. The school is required to increase the rate of DA from 30%.
4. Other conditions as per Annexure 'A' (enclosed).

Compliance of the conditions should reach to this office within three months.


